Fremont Council President's Message by Melinda Kufeld

How important is the future of your PTA?

The nominating committee ('nom com') is one of the most important and sadly, guite often over looked PTA committees. The 'nom com' is responsible for identifying next year's PTA officers and shaping the future of your PTA.

Most of you probably think I'm nuts to mention the 'nom com' before trick and treaters have even shown up at your door step. I agree it is early in the school/PTA year to think about next year's board, but for units with three or four association meetings annually, it will soon be time for the 'nom com' to be elected by your association.

Per the bylaws, all Fremont PTAs are to hold their annual election in either March or early April. The association is to be given 30 days notice of the annual election and the slate of officers. The 'nom com' needs time to do their work so they should be elected no later than three months before the annual election. Check your bylaws for the month your annual election is to be held and when your unit is to hold association meetings; then get the election of your nominating committee on the calendar! Yes, it's not ideal to elect your 'nom com' before the end of the calendar year. However, it's better for them to be in place and ready to start their work right after the New Year, than to not give this critical committee the time they need to complete the task of identifying next year's officers.

At our November 5th council meeting, Fremont Council PTA parliamentarian Lisa Ogrey will bring y'all up to speed with the nominating committee to include tips for gathering an effective group to shape the future of your PTA. Make sure to bring your bylaws with you to the meeting!

Other ways to ensure your PTA will be strong in the future:

- Attend training
- Review bylaws, PTA Toolkit and insurance guide
- Recruit, manage, and value volunteers
- Identify and mentor new chairpersons and officers
- Check out plentiful PTA on-line resources found on council's, CA State PTA's and National PTA's websites
- Plan to attend CA State PTA convention in San Jose May 2nd 5th
